**Vegetables and Flowers:** Mix 1 ½ ounces (3 tablespoons) per gallon of water. Pour around new transplants or established plants. Use every 3 to 4 weeks throughout the growing season.

Indoor Plants: Mix ½ ounce (1 tablespoon) per quart of water. Pour around new transplants or established plants. Use monthly.

Lawn Use: Pour concentrated HuMate into hose-end-sprayer. Set dial to 1½ ounces (3 tablespoons) per gallon of water. Attach hose-end sprayer to hose. Apply evenly across the lawn.
